## Photography and Video Policy.

Flying Start feel it is important for parents to celebrate their child's journey through the nursery and believe it can enhance self —esteem within the children and can be a source of pleasure and pride.

We ask parents to give written permission so we can take photographs / videos of their children participating in play activities during nursery hours. All photographs taken by staff are solely used for nursery purposes e.g. child observations, evidence of activities and topics. Photographs may involve group situations with other children and so may be seen with their friends on Tapestry observations photos and videos.

We stipulate that they have the right to withdraw their consent at any stage but this must be made so in writing. The parents also agree that any photos MUST NOT be placed on any Social Network sites such as Facebook, twitter etc.....

All photographs on the mobile phone and ipads are maintained securely and disposed of in the appropriate manner. All work computers have necessary passwords and codes to gain access to files containing personal data.

Flying Start will periodically invite an official photographer into our setting to take portraits/photographs of individual children and or groups. Flying Start will check validity of the photographer and agency involved and ensure levels of supervision are appropriate to safeguarding the welfare of the children at all times when visitors are present.

## **Observations and Photographs**
